#### **FOOD AND BEVERAGE**

Picnics are encouraged. There will be food and beverages available for purchase outside the venue.

#### ALCOHOL IS PROHIBITED IN FROST AMPHITHEATER

You may be required to open your beverage containers for review prior to entering the amphitheater.

Persons in possession of alcohol or who are visibly intoxicated will be denied entry, or are subject to removal from the venue, with no refund.

#### FROST IS A NON-SMOKING VENUE

Frost Amphitheater is a smoke-free environment. No smoking of **ANY** kind (including ecigarettes) will be tolerated inside or in the immediate vicinity outside of Frost, within 30 feet of the venue, and within 30 feet of ticket lines and vendor sales areas. Those who are found smoking inside the venue may be subject to removal with no refund.

All persons & bags are subject to search upon entry and while inside the venue at the discretion of the management and the Stanford University Department of Public Safety (SUDPS). Metal wands will be used prior to entry.

#### PROHIBITED ITEMS IN THE AMPHITHEATER

- No professional cameras (i.e. with detachable lenses), audio recording and video taping equipment are allowed without prior written permission from the management. No GoPro cameras, drones or selfie sticks.
- No portable chairs.
- No glass bottles, metal containers, or pre-filled beverage reservoirs (i.e. CamelBaks).
- No fireworks, lighters, grills, and stoves.
- No firearms, knives, and other weapons.

- No strollers, skateboards, roller skates, bicycles or scooters.
- No animals unless assisting an individual with a disability.
- No lawn chairs, balls, flags, frisbees, or umbrellas of any kind.

Prohibited items will either be confiscated or you will need to return them to your vehicle. Stanford University is not responsible for storing your confiscated items during the duration of the festival.

## PERMITTED ITEMS AND ACTIVITIES

- You are encouraged to bring a picnic. Frost is best enjoyed on a blanket with your friends and family.
- Unopened non-alcoholic beverage containers no glass or metal.
- Empty plastic refillable water containers no glass or metal.
- Blankets
- Binoculars
- Small seat cushions
- Backpacks/bags smaller than 16"Wx14"Hx12"D
- Coolers Soft-sided only, and not larger than 16"W x14"H x 12"D, maximum size.

#### **EXIT AND RE-ENTRY RULES**

- Ticket Holders may leave the venue through the designated GATE 2 area marked EXIT/ RE-ENTRY.
- You will be given a special wristband **BEFORE** leaving as a condition of re-entry into Frost back into GATE 2.
- Wristbands void if tampered with and may prohibit re-entry.
